PAYMENT PLAN OPTIONS:

1.) Standard Monthly Payment Plan

Description:

Guests pay in equal monthly instalments leading up to one month before the retreat starts (the retreat is paid in full by this point).

Example for Solo Guest:

- Total Cost: €4,500
- Monthly Payment: $\text{€}4,500 / 7 = \text{€}643$ per month
 - *Assuming a 7-month payment duration for April 2025 retreat starting 1st September 2024*

Example for Sharing Per Person:

- Total Cost: €4,300 per person
- Monthly Payment: $\text{€}4,300 / 7 = \text{€}615$ per person per month
 - *Assuming a 7-month payment duration for April 2025 retreat starting 1st September 2024*

2.) Deposit Plus Instalments

Description:

Guests pay an initial deposit to secure their spot, followed by the remaining balance in monthly instalments. Guests pay in equal monthly instalments leading up to one month before the retreat starts (the retreat is paid in full by this point). **Deposit: 20% of the total cost.*

Example for Solo Guest:

- Initial Deposit (first month payment): $€4,500 \times 20\% = €900$
 - Remaining Balance: $€4,500 - €900 = €3,600$
- Monthly Payment: $€3,600 / 6 = €600$ per month
 - *Assuming a 6-month payment duration for April 2025 retreat starting 1st September 2024*

Example for Sharing:

- Initial Deposit (first month): $€4,300 \times 20\% = €860$ per person
 - Remaining Balance: $€4,300 - €860 = €3,440$ per person
- Monthly Payment: $€3,440 / 6 = €574$ per person per month
 - *Assuming a 6-month payment duration for April 2025 retreat starting 1st September 2024*

3.) Pay in Full for Discount:

Description:

- Guests who pay the entire cost upfront receive a discount.
- Discount: €300 off the total cost for both solo and sharing options.

Example for Solo Guest:

- Total after Discount: €4,500 - €300 = €4,200

Example for Sharing:

- Total after Discount: €4,300 - €300 = €4,000 per person

Payment Plan Notes

- Monthly payments start either mid-August or 1st September and end approximately one month prior to the retreat of choice start date. *Should you want to arrange a shorter or longer payment plan, this can be discussed (see next page).*
